BONUS DOLLARS REIMBURSEMENT

- Bonus Dollars can be used on a reimbursement basis by any Independent Representative (Rep) booking eligible travel. After receiving necessary receipts and proof of travel, WorldVentures™ will reimburse the Rep in accordance with applicable terms.
- A minimum of US\$100 or equivalent in eligible travel expenses is required to redeem Bonus Dollars.
- Any receipts that exceed the available balance of Bonus Dollars must be resubmitted when a sufficient balance of Bonus Dollars is available. If a single travel receipt totals more than the Rep's available balance of Bonus Dollars, that receipt is eligible for partial reimbursement of Bonus Dollars. However, partially reimbursed receipts may not be submitted again for reimbursement.
- Bonus Dollars expire one year from the date they are awarded.
- Bonus Dollars will be redeemed at a rate of US\$1 for each US\$1 spent on eligible travel expenses and will be rounded up to the nearest US dollar. Foreign currencies will be converted to US dollars for reimbursement purposes.
- Please allow ten business days for processing of a Bonus Dollars reimbursement payment.

TRAVEL ELIGIBILITY CRITERIA

In order to be eligible for reimbursement, travel expenses must also meet the following requirements:

- *Only airfare, transfers, car rental, taxis, shuttles, hotel, airport and hotel parking fees, Wi-Fi connection fees and cruises are eligible for redemption. Other travel-related expenses such as food, entertainment, hotel amenities, minibar and room service are not eligible for reimbursement.
- **Only eligible travel purchases used directly by a WorldVentures Rep or an immediate family member accompanying the Rep are eligible for reimbursement. Bonus Dollars are not transferable but can be redeemed by the Rep's immediate family, defined as a spouse and dependent children residing with the Rep parent or legal guardian who are unmarried, in school, and are 25 years of age or under. A disabled child, no matter what age, but under the direct care of his/her Rep parent or legal guardian is considered a dependent child.
- Travel must have taken place and been paid for prior to requesting Bonus Dollars redemption.
