TRAVEL INSURANCE:

Travel insurance is required for each person participating in a WorldVentures Foundation VolunTour DreamTrip.

You can purchase travel insurance from your regular insurer, or from a specialist travel insurance company. Two options are Travel Guard and Travel Insured.

MINIMUM REQUIREMENTS:

Whichever travel insurance you choose, it must meet the following **minimum requirements**:

WorldVentures Foundation VolunTour Release

In consideration for the agreement of WorldVentures Foundation (“WV Foundation”) to allow you to participate in a WV Foundation VolunTour, you hereby agree to the following terms and conditions.

Disclosure: You understand and acknowledge that, participation in the WV Foundation VolunTour involves unpredictable or inherent risks of personal injury and even death from dangers that may arise, including, but not limited to, acts of God, the hazards of traveling in unsafe conditions or politically unstable areas, the dangers of civil disturbances, war, extortion, kidnapping, and terrorist activities, the forces of nature, dangers and risks inherent in volunteer activities in underdeveloped countries, dangers and risks of travel by bus, boat, automobile, train, ship, aircraft, or other means of conveyance, inaccessibility to persons with certain disabilities, local law enforcement activity, and accident or illness in remote places without access to medical facilities, transportation, or means of rapid evacuation and assistance. You hereby elect to voluntarily participate in the WV Foundation VolunTour and acknowledge that you know of no medical reason(s) why you should not participate in this WV Foundation VolunTour.

Insurance: WV Foundation recommends that you purchase travel insurance to cover your VolunTour. WV Foundation may provide hosts for VolunTours but does not guarantee any on site assistance with emergency medical or other needs. You acknowledge that you are responsible for your own insurance coverage in the event of personal injury or illness as a result of your services to WV Foundation.

Disclaimer: WV Foundation shall not be responsible for any injuries, damages, or losses to you or your property caused by or arising out of or in connection with any of the above risks and dangers or any other actions, omissions, or conditions outside WV Foundation’s control.

Release: YOU DO HEREBY EXPRESSLY ASSUME ALL OF THE RISKS AND DANGERS NOTED IN THE DISCLOSURE PARAGRAPH ABOVE, AND EXPRESSLY AGREE FOREVER TO RELEASE, WAIVE, DISCHARGE, COVENANT NOT TO SUE AND HOLD WV FOUNDATION and their agents, employees, officers, directors, associates, affiliated companies, hosts, guides, group leaders, or subcontractors (“Releasees”) HARMLESS against any and all liability, actions, causes of actions, suits, claims, and demands of any and every kind and nature whatsoever which you now have or which may hereafter arise out of or in connection with your VolunTour participation in any activities arranged by WV Foundation, regardless of whether such loss is caused by the negligence of the Releasees and regardless of whether such liability arises in tort, contract, strict liability or otherwise.

In consideration for being permitted to participate in the WV Foundation VolunTour, you further covenant and agree to indemnify and hold harmless the Releasees from any loss, liability, damage or costs, including attorneys’ fees and court costs, they may incur arising out of or related to your participation in the WV Foundation VolunTour, whether caused by the negligence of the Releasees or otherwise, including as a result of negligent rescue operations.

You further covenant and agree that this Release shall be construed in accordance with the laws of the State of Texas and that any mediation, suit or other proceeding relating to this Release and any activities



covered hereby must be filed or entered into only in Texas and the federal or state courts of Texas, USA. Any portion of this Release deemed unlawful or unenforceable is severable and shall be stricken without any effect on the enforceability of the Release as a whole to the full extent authorized by law.

Publicity:

You authorize WV Foundation, its representatives and employees the right to photograph, video tape or use any other mechanical means of recording or reproducing images of yourself, minor participants for whom you are a parent or legal guardian in connection with the WVF VolunTour and to use your likeness and, if applicable, the likeness of the minor(s). You further acknowledge and hereby grant to WV Foundation, the worldwide and perpetual right and authority to use, reproduce, distribute, broadcast or otherwise transmit, publish and/or display in whole or in part, your name, photograph, any other likeness and/or biographical information you have provided and, if applicable, the minor(s)' name, photograph, any other likeness and/or biographical information you have provided, and any statement you have made or may make concerning the WVF VolunTour in any and all media now known or hereafter invented, in perpetuity, for purposes including but not limited to trade, promotion, publicity, and/or web content without notification, compensation, royalty or additional consideration, except where prohibited by law.

THE TERMS OF THIS AGREEMENT SHALL SERVE AS A COMPLETE RELEASE AND EXPRESS ASSUMPTION OF RISK for yourself, minor participants for whom you are a parent or legal guardian, your heirs, assignees, administrators, guardians, legal representatives and executor. YOU HAVE READ AND FULLY UNDERSTAND THE PROVISIONS AND THE LEGAL CONSEQUENCES OF THIS RELEASE AND ASSUMPTION OF RISK, AND YOU HEREBY AGREE TO ALL OF ITS CONDITIONS. You acknowledge that in calculating the cost of the VolunTour, WV Foundation has relied on your consent to these terms and on their enforceability. In the absence of this Release, the VolunTour cost would have been higher, or, alternatively, WV Foundation would have been unable to offer these services.
