The new Holiday Rank Up promotion might be the push you need to close the year strong. If you meet all the qualifications and maintain your new paid rank throughout 2019, you'll be eligible to receive a sizable bonus, payable over the course of 12 months. First, complete the following:

- 1. Make at least two personal sales** of any DreamTrips™ Membership level between 26 Oct. and 3 Dec. or 17 and 31 Dec. 2018. If a new Representative joins WorldVentures™ after 27 Oct. 2018, they have three weeks from the date they join to meet this qualification.
- 2. Rank up to Director, Marketing Director or Regional Marketing Director** — and meet additional lineage requirements — between 26 Oct. 2018 and 4 Jan. 2019.

After completing these steps, you'll be eligible for a bonus payout of **\$5,000 if you rank up to Director** and **\$10,000 if you rank up to Marketing Director or Regional Marketing Director**.

**But wait ... there's more.** If you qualify for this promotion and you attended *A View from the Edge* in 2018, your bonus will double for a total payout of up to **\$20,000**.

# FREQUENTLY ASKED QUESTIONS

## What is the Holiday Rank Up promotion?

Holiday Rank Up is an opportunity for Representatives with a paid rank of Marketing Director or below (as of 26 Oct. 2018) to earn a monthly bonus based on their personal sales, highest achieved and maintained paid rank, and new lineage added in a given time period.

## When is the promotional period?

The overall promotion ends 4 Jan. 2019; however, Active Reps must meet the first qualification requirement, to make at least two personal sales of any DreamTrips Membership level, by 3 Dec. or between 17 and 31 Dec. 2018. If a new Representative joins WorldVentures after 27 Oct. 2018, they have three weeks from the date they join to meet this qualification. Additionally, the newly achieved paid rank must be maintained over the 12-month period in 2019 to receive the full bonus amount.

## Which markets can participate in this promotion?

This promotion is available in all markets.

## What additional lineage requirements must be met?

Reps who achieve the paid rank of Director must bring in 50 new lineage, and those who rank up to Marketing Director or Regional Marketing Director must bring in 100 new lineage by 4 Jan. 2019.

## Will the Fast Pass 150 promotion apply to lineage generated toward the Holiday Rank Up lineage requirements?

## Is it possible to complete Step 2 (achieving the next paid rank of Director, Marketing Director or Regional Marketing Director) before Step 1 (the personal sales qualification)?

Yes, depending on how close a Rep is to achieving their next paid rank when the promotion starts. Most Reps who qualify for the bonus payout will complete the steps in order, but it is possible to complete them out of order.

## How will the bonus payout be determined?

The bonus amount will be determined based on the highest paid rank (of Director or Marketing Director or Regional Marketing Director), the new lineage requirements achieved during the qualification period and how long the newly achieved paid rank is maintained throughout 2019.

Additionally, if you attended *A View from the Edge* in 2018, your bonus payout will be doubled — from \$5,000 to \$10,000 for Directors, and from \$10,000 to \$20,000 for Marketing Directors and Regional Marketing Directors.

## When will the bonus be awarded?

Reps who qualify will receive their bonus over the course of 12 months, starting with the 15 Feb. 2019 monthly commission run, as long as they maintain the paid rank they achieved during the qualification period. Each Rep will be given one grace month during the 12-month payment process. If the newly achieved paid rank and lineage requirements are not maintained after the grace month, the remainder of the bonus instalments will be forfeited.

## Here's a breakdown, by rank, of the monthly bonus payout, as long as the new paid rank is maintained throughout 2019:

Paid Rank Achieved	New Lineage Added	Bonus without View 2018 attendance	Bonus with View 2018 attendance
Director	50	\$5,000 (\$416.67 per month*)	\$10,000 (\$833.33 per month*)
Marketing Director	100	\$10,000 (\$833.33 per month*)	\$20,000 (\$1,667.67 per month*)
Regional Marketing Director	100	\$10,000 (\$833.33 per month*)	\$20,000 (\$1,667.67 per month*)

\*Monthly bonus payouts are only paid out if the newly achieved paid rank of Director, Marketing Director or Regional Marketing Director is maintained for at least 12 consecutive months, with one grace month allowed.
