

Privacy Policy - Taiwan

Effective as of: May 1, 2015

Introduction

WorldVentures Taiwan Ltd. ("**WorldVentures**", "**Company**", or "**we**") respect your privacy and are committed to protecting it through our compliance with this policy.

This policy and any other documents referred to in it describe the personal information that we collect from you, or that you provide on this website worldventures.com (our "**Website**") (which may link to other WorldVentures websites) and how that information may be used or disclosed by us.

This Privacy Policy relates to information we collect on this website, in email, text and other electronic messages between you and this Website and us, through mobile and desktop applications you download from this Website, which provide dedicated non-browser-based interaction between you and this Website and when you interact with our advertising and applications on third-party websites and services, if those applications or advertising include links to this policy.

Other WorldVentures websites may contain privacy policies which are different from this Privacy Policy. In addition, specific terms and conditions may apply to specific content, services or products contained in or available from such other WorldVentures websites. In the event such additional or specific terms are inconsistent with the terms contained in this Privacy Policy, the additional or specific terms shall prevail. On your visits to WorldVentures websites please check the privacy policy of each website which you visit and do not assume that this privacy policy applies to all WorldVentures websites.

This policy does not apply to information collected on any third-party site or by any third-party application that may link to or be accessible from the Website, unless such third party site or third party application includes links to this policy.

Please read the following carefully to understand our policies and practices regarding your personal information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our Website. By using or accessing our Website, you agree to this privacy policy. This policy may change from time to time and your continued use of the Website is deemed to be acceptance of such changes, so please check the policy periodically for updates.

Children Under the Age of 20

Our Website is not intended for children under 20 years of age. No one under age 20 may provide any personal information to or on the Website. We do not knowingly collect personal information from children under 20. If you are under 20, please do not register on the Website, make any purchases through the Website or send any information about yourself to us, including your name, address, telephone number or email address. In the event that we learn that we have collected personal information from a child under age 20 without verification of parental consent, we will delete that information. Information We Collect About You and How We Collect It

We collect several types of information from and about users of our Website, including:

- Information you provide to us.
- Information we collect as you navigate through the site, including usage details, IP addresses.
- Information we receive from third parties, for example, our business partners and independent sales representatives.
- Information about your internet connection, the equipment you use to access our Website and usage details.

We collect this information:

- Directly from you when you provide it to us.
- Automatically as you navigate through the site. Information collected automatically may include usage details, IP addresses and information collected through cookies, web beacons and other tracking technologies.
- From third parties, for example, our business partners.

Information You Provide to Us

We may collect and use the following information that you provide to us:

- Information that you provide by filling in forms on our Website. This includes information provided at the time of registering to use our Website, subscribing to our services, posting material or requesting further services. We may also ask you for information when you enter a contest or promotion sponsored by us, and when you report a problem with our Website.

- Records and copies of your correspondence (including email addresses), if you contact us.
- Your responses to surveys that we might ask you to complete for research purposes, although you do not have to respond to them.
- Details of transactions you carry out through our Website and of the fulfillment of your orders. You may be required to provide financial information before placing an order through our Website.
- Your search queries on the Website.

You understand and agree that the above information includes but is not limited to:

- Identification class: name, identification number, e-mail address, photos, videos, and other data of such a nature that it may identify you personally,
- Feature class: gender, date of birth,
- Financial: credit card number,
- Family: friends and social relationship,
- Employment situation: current and past service unit, and/or
- Other: IP address, your general Internet usage patterns

Usage Details, IP Addresses, Cookies and Other Technologies

- **Usage Details and IP Addresses.** As you navigate through the Website, we may also collect details of your visits to our Website, including, but not limited to, traffic data, location data, logs and other communication data, whether this is required for our own billing purposes or otherwise and the resources that you access, as well as information about your computer and Internet connection, including your IP address, operating system and browser type, for system administration and to report aggregate information to our advertisers. This is statistical data about our users' equipment, browsing actions and patterns, and does not identify any individual.
- **Cookies.** For the same reason, we may obtain information about your general Internet usage by using cookies. A cookie is a small file stored on the hard drive of your computer. Use of cookies help us to improve our Website and to deliver a better and more personalized service by enabling us to:
 - Estimate our audience size and usage patterns.
 - Store information about your preferences, allowing us to customize our Website according to your individual interests.
 - Speed up your searches.
 - Recognize you when you return to our Website.

You may refuse to accept cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Website. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to our Website.

- **Web Beacons.** Pages of the Website may contain electronic images known as web beacons (also referred to as single-pixel gifs) that permit the Company to count users who have visited those pages and for other related website statistics (for example, recording the popularity of certain website content and verifying system and server integrity). Web beacons are not used to access your personal information on the Website and are only used to compile aggregated statistics concerning use of the Website.
- **Third-Party Advertiser Use of Cookies and Other Tracking Technologies.** Some advertisements on the Website are served by third-party advertising companies. Please note that our advertisers may also use cookies alone or in conjunction with web beacons or other tracking technologies to collect information about our users. We do not have control over third-party advertisers' cookies or how they may be used. If you have any questions about an advertisement, you should contact the responsible advertiser directly.

User Contributions

You are responsible for any content, including personal information, that you contribute to be published or displayed (hereinafter, "**posted**") on the Website, or transmit to other users of the Website (collectively, "**User Contributions**"). Your User Contributions are posted on and transmitted to other users of the Website at your own risk. Please be aware that no security measures are perfect or impenetrable. Additionally, we cannot control the actions of other users of the Website with whom you may choose to share your User Contributions.

Therefore, we cannot and do not guarantee that your User Contributions will not be viewed by unauthorized persons. We are not responsible for circumvention of any privacy settings or security measures contained on the Website. You understand and acknowledge that, even after removal, copies of your User Contributions may remain viewable in cached and archived pages, or might have been copied or stored by other Website users.

Uses Made of the Information

We collect and use information that you provide to us, including any personal information, for the following purposes:

- To check your identity.
- To contact you, send billing information, and send merchandise and promotional brochures.
- To provide our promotional activities information.
- To improve our customer services, informative services, management of advertising or commercial behavior, and other e-commerce services.
- To present our Website and its contents in a suitable and effective manner for you and for your computer.
- To provide you with information, products or services that you request from us.
- To carry out our obligations and enforce our rights arising from any contracts entered into between you and us.
- To notify you about changes to our service.
- To allow you to participate in interactive features of our service, when you choose to do so.
- In any other way we may describe when you provide the information.
- For any other purpose with your consent.
- Other purposes which match our business registration items.

We may also use your information, or permit selected third parties to use your information, to contact you about goods and services that may be of interest to you where you have consented to be contacted for such purposes. If you do not want us to use your information in this way, or to provide your information to third parties for marketing purposes, please send us an email with the subject line "unsubscribe" to privacy@worldventures.com.

We do not disclose your personally identifiable information to our advertisers, but we may provide them with aggregated information about our users (for example, we may report to them that 500 men aged under 30 clicked on their advertisement on a given day). We may also use such aggregated information to help advertisers reach the kind of audience they want to target. We may make use of the personal information we have collected from you to enable us to comply with our advertisers' wishes by displaying their advertisement to that target audience. Even though we only disclose aggregate information that is not personally-identifiable to advertisers without your consent, when you click on or otherwise interact with an advertisement there is a possibility that the advertiser may assume that you meet the target criteria they selected.

Disclosure of Your Information

We may disclose personal information that you provide via this Website to the following third parties:

- Our holding entities, subsidiaries and affiliates.
- Other users of this Website.
- Contractors including WorldVentures Independent Sales Representatives and service providers we use to support our business.
- To a buyer in the event of a merger, divestiture, restructuring, reorganization, dissolution or any other form of sale of some or all of WorldVentures Taiwan Ltd.'s assets or those of its holding company or entity, whether as a going concern or as part of bankruptcy, liquidation or similar proceeding, in which personal information held by WorldVentures Taiwan Ltd. about its customers is among the assets transferred.
- To third parties to market their products or services to you if you have not opted out of these disclosures. We contractually require these third parties to keep personal information confidential and use it only for the purposes for which we disclose it to them.
- To fulfill the purpose for which you provide it.
- For any other purpose disclosed by us when you provide the information.
- With your consent.

We may also disclose your personal information to third parties to:

- Comply with any court order or other legal obligation.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of WorldVentures Taiwan Ltd., our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.

Choices About How We Use and Disclose Your Information

We strive to provide you with choices regarding the personal information you provide to us. We have created mechanisms to provide you with the following control over your information:

- **Cookies.** If you do not wish us to collect cookies, you may set your browser to refuse cookies, or to alert you when cookies are being sent. If you do so, please note that some parts of this site may then be inaccessible or not function properly.

- **Promotional Offers from Third Parties.** If you do not wish us to share your personal information with unaffiliated or non-agent third parties for promotional purposes, you can opt-out by sending an email with the subject line “unsubscribe” to privacy@worldventures.com.
- **Promotional Offers from the Company.** If you do not wish to have your email address used for promotional purposes by the Company, you can opt-out by sending an email with the subject line “unsubscribe” to privacy@worldventures.com. You can also always opt-out of receiving email information from us other than the email informing you of the completion of user registration, correction of user data, change of password or change of applicable terms and conditions by sending us an email stating your request at privacy@worldventures.com. If we have sent you a promotional email, you may send us an email at privacy@worldventures.com asking to be omitted from future email distributions. This opt out does not apply to information provided to the Company as a result of a product or service purchase, product service experience or other transactions.
- **Personalized Advertising.** If you do not want us to use personal information that we gather to allow third parties to personalize advertisements we display to you, you can opt-out by sending an email with the subject line “unsubscribe” to privacy@worldventures.com.

We do not control third parties' collection or use of your information to serve interest-based advertising. However these third parties may provide you with ways to choose not to have your information collected or used in this way. You can opt out of receiving targeted ads from members of the Network Advertising Initiative ("NAI") on the NAI's website.

You should review this privacy policy carefully, because if you do not agree with our practices, your ultimate choice is not to use the Website. Remember, by using any part of the Website, you accept and agree to our privacy practices. If we update this privacy policy, your continued use of the Website (following the posting of the revised privacy policy) means that you accept and agree to the terms of the revised privacy policy.

Other Clauses about Your Personal Information

Unless otherwise noted, we will process and use your personal information during your membership period until you notify us to stop processing or using it, or to delete it.

We will make use of your aforementioned personal information in Taiwan and in the countries of WorldVentures Holdings, LLC and its affiliated United States subsidiaries including WorldVentures Marketing, LLC, and at the location of the network server and our relevant services or marketing activities.

We will use and process your personal information by automated and non-automated manners in accordance with the Personal Information Protection Act and its Enforcement Rules.

You can choose whether to provide your personal information or to allow this Website to collect, process, or use your personal information for the above purposes. If you do not want to provide or fully provide the requested personal information, we may not be able to provide you optimal service and some parts of this Website may then be inaccessible or unable to function properly.

You can exercise the following rights if we confirm that the personal information is yours.

- To inquiry and request for a review of your personal information.
- To request to make duplications of your personal information.
- To request to supplement or correct your personal information.
- To request to discontinue collection, processing or use of your personal information.
- To request to delete your personal information, though note that we cannot delete your personal information except by also deleting your user account.

Accessing and Correcting Your Personal Information

Data Security

We have implemented measures designed to secure your personal information from accidental loss and from unauthorized access, use, alteration and disclosure. All information you provide to us is stored on our secure servers behind firewalls. Any payment transactions and personally identifiable information will be encrypted using SSL technology.

The safety and security of your information also depends on you. Where we have given you (or where you have chosen) a password for access to certain parts of our Website, you are responsible for keeping this password confidential. We ask you not to share your password with anyone. We urge you to be careful about giving out information in public areas of the Website like message boards. The information you share in public areas may be viewed by any user of the Website.

Unfortunately, the transmission of information via the Internet is not completely secure. Although we do our best to protect your personal information, we cannot guarantee the security of your personal information transmitted to our Website. Any transmission of personal information is at your own risk.
