

The Lifestyle Bonus has been one of the most popular and successful programmes in WorldVentures™ history. Since its inception, thousands of Representatives have qualified for payments through this programme. We've compiled a list of questions and answers to clarify everything about the Lifestyle Bonus. If we missed anything, let us know and we'll get your question answered, too.

**Q. When is the bonus effective?**

A. Effective 4 February 2017.

**Q. What is the minimum sales volume required to qualify for this new bonus?**

A. Qualification begins at just US\$1,600 in volume through your lineage organisation. (See additional requirements illustrated below.)

**Q. What does it take to qualify for the Lifestyle Bonuses? And how much is the payout?**

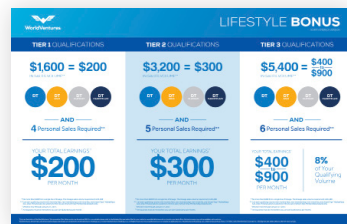
A. There are three tiers to the bonus.

Tier 1 pays US\$200/month. You can qualify for the Tier 1 bonus with US\$1,600 in Lineage Sales Volume and four Active personal customers of DreamTrips™ Membership products. No more than US\$400 in volume can come from a single line of lineage.

Tier 2 pays US\$300/month. You can qualify for the Tier 2 bonus with US\$3,200 in Lineage Sales Volume and five Active personal customers of DreamTrips Membership products. No more than US\$1,667 in volume can come from a single line of lineage.

At Tier 3, the bonus pays 8% of Lineage Sales Volume at or above US\$5,400 up to US\$11,250, so Reps who meet the requirements can receive up to US\$900 per month (8% of US\$11,250 in volume). To qualify for the Tier 3 bonus, you need at least US\$5,400 in Lineage Sales Volume and six Active personal customers of DreamTrips Membership products. As with Tier 2, no more than US\$1,667 in volume can come from a single line of lineage.

**Q. How can I create volume that applies towards the Lifestyle Bonus?**

A. Your personal sales of DreamTrips Membership products — initial and monthly fees — and your personal sales from the DreamTrips MarketPlace count towards your Lifestyle Bonus. Volume created in your lineage organisation for these products also counts on a dollar-for-dollar basis, but refer to the volume chart in the back office. Spillover volume — that is, volume created by Representatives in your binary organisation who do not belong to one of your lines of personal sponsorship — does not count towards this bonus.

**Q. Do my purchases for personal consumption count towards the bonus?**

A. No. Only your personal sales to others count towards the bonus. However, any Membership or DreamTrips MarketPlace products purchased in your lineage organisation count towards your Lifestyle Bonus volume, even if some of these purchases are for personal consumption by members in your downline.

**Q. I've already earned my 600 Rovia® Bucks Bonus. Do I lose money with this programme if my volume is closer to US\$5,000 than to US\$11,250?**

A. No. If you qualified for the US\$600 or 600 Rovia Bucks Bonus at any time under the previous programme, we've instituted special "grandfathering" rules to ensure you continue to receive compensation at that level as long as you continue to qualify. Assuming you achieve at least US\$5,400 in Lineage Sales Volume, with no more than US\$1,667 coming from a single leg and six Active personal sales, your payout for that month will be no less than you were entitled to under the old programme, even if 8% of your actual Lineage Sales Volume works out to be less than that.

**Q. Are there still grace months for those who miss qualifying for the bonus?**

A. In general, no. If you qualify for the bonus in a given month, you receive the payout. If you find that you are not on track for qualifying for the bonus, the DreamTrips MarketPlace provides a powerful mechanism to generate more volume. However, for those who are subject to the grandfathering rules mentioned in the previous question, grace months will continue to apply.

**Q. Can you show me some examples of how the grandfathering and grace-month provisions work for those who were receiving a US\$600 or 600 Rovia Bucks Bonus under the old programme?**

A. Sure. Here are a couple of timelines illustrating how the grandfathering and grace-month rules could play out. Both of these examples assume that the Rep qualified for the US\$600 or 600 Rovia Bucks Bonus at some point prior to 10 April 2014.

# EXAMPLE 1

MONTH	BONUS REQUIREMENTS MET	BONUS PAID OUT	RATIONALE
April	Meets Tier 3 Lifestyle Bonus requirements	US\$600 or 8% of volume, whichever is greater	
May	Misses Tier 3 requirements	US\$600	Grace month
June	Meets Tier 3 Lifestyle Bonus requirements	US\$600 or 8% of volume, whichever is greater	
July	Misses Tier 3 requirements	US\$600	Grace month
Aug.	Misses Tier 3 requirements	No Tier 3 Bonus; receives US\$300 Tier 2 Bonus, if qualified	Must requalify for Tier 3 Bonus
Sept.	Meets Tier 3 Lifestyle Bonus requirements	US\$600 or 8% of volume, whichever is greater	Requalifies. Still receives US\$600 floor, but no more grace months from this point

## EXAMPLE 2

MONTH	BONUS REQUIREMENTS MET	BONUS PAID OUT	RATIONALE
April	Meets Tier 3 Lifestyle Bonus requirements	US\$600 or 8% of volume, whichever is greater	
May	Misses Tier 3 requirements	US\$600	Grace month
June	Meets Tier 3 Lifestyle Bonus requirements	US\$600 or 8% of volume, whichever is greater	
July	Misses Tier 3 requirements	US\$600	Grace month
Aug.	Meets Tier 3 Lifestyle Bonus requirements	US\$600 or 8% of volume, whichever is greater	
Sept.	Meets Tier 3 Lifestyle Bonus requirements	US\$600 or 8% of volume, whichever is greater	
Oct.	Misses Tier 3 requirements	No Tier 3 Bonus; receives US\$300 Tier 2 Bonus if qualified	Must requalify for Tier 3 Bonus
Nov.	Meets Tier 3 Lifestyle Bonus requirements	US\$600 or 8% of volume, whichever is greater	Requalifies. Still receive US\$600 floor, but no more grace months from this point
