What are the dates of the Ignition Kit 4.0 promotion?

The promotion begins July 18, 2020, and ends October 23, 2020.

What is the price for the Ignition Kit 4.0?

Refer to Table A on page 2. The prices are inclusive of applicable tax and are in U.S. dollars, unless stated otherwise.

Is the Ignition Kit refundable?

Ignition Kits are nonrefundable.

Who can buy an Ignition Kit 4.0?

All new or current Reps can purchase the Ignition Kit 4.0 for access to valuable training.

Where can I purchase the Ignition Kit 4.0?

You can buy your Ignition Kit 4.0 through the upgrade flow, available in the back office. Consultants in Brazil will need to call customer service to purchase.

How will I receive my audios?

Once you have successfully purchased the Ignition Kit 4.0, you'll receive an email with a link to all the training audios. Make sure to verify that the email address you have on file is accurate to ensure there aren't any delivery interruptions of the welcome email.

What is the lineage boost associated with the Ignition Kit 4.0?

To receive a lineage boost, a Rep will need one of their personally sponsored Reps to purchase Ignition Kit 4.0. Once a personally sponsored Rep purchases 4.0, the lineage boost will be triggered for all new sales within the sponsoring Rep's lineage.

When does the lineage count boost end?

Qualifying sales will receive the lineage boost through February 12, 2021.

Will there be any additional benefits to the compensation plan?

No other direct compensation plan benefits will be provided to you for the purchase of the Ignition Kit 4.0. You participate in the standard compensation plan bonuses and commissions as described in your market's WorldVentures™ Compensation Plan.

If I purchased previous Ignition Kits, will all my qualified sales boost extend to February 12, 2021?

No, but If a Rep purchased Ignition Kit 3.0 and one of their personally sponsored Rep purchases Ignition Kit 4.0, their lineage boost for the sales associated with Ignition 3.0 will be extended to February 12, 2021. See **Table C**.

Will reactivated accounts receive the lineage boost?

No, reactivated accounts are not eligible to receive the lineage boost during the promotion period.
