FREQUENTLY ASKED QUESTIONS

What is the Leap to V.I.P. promotion?

Two *UNITED* V.I.P. experiences are offered.

What are the promotion periods?

Can I bring a guest to the backstage meet-and-greet and mix & mingle?

Yes, the qualifier may bring their spouse, significant other or legal business partner. Limit of two attendees per qualifying position.

What are the qualifying rules?

To qualify, Reps must be one of the top 10 sales producers in one of three regions: the Americas, APAC or EMEA. Personal sales must occur between 1 Feb. 2020 midnight and 29 Feb. 2020 11:59pm or 1 March 2020 midnight and 31 March 2020 11:59 p.m. CST. Other criteria are:

- ◇ Sales are based on enrolments of new DreamTrips members, not sponsorships.
- ◇ Enrolment transfers will not change qualifications. Only the original enrolments will count, not the transferred accounts.
- ◇ RBS-only accounts that enrol as a new member will not count as a sale toward this promotion.
- ◇ Upgrade of membership will not count as a sale toward this promotion.
- ◇ Reactivations of a membership will not count as a sale toward this promotion.
- ◇ The top 60 Reps must be active and in good standing during the entirety of the promotion and during *UNITED 2020*.

- ◆ If one of the qualifying accounts is owned by multiple business partners, each partner will be considered a qualifier. Limit of two attendees per qualifying position.
