FREQUENTLY ASKED QUESTIONS

What is the Pick Up Six Promotion?

With the Pick Up Six promotion, you can earn a share of a \$300,000 bonus pool, split between 3 regions, when you pick up 6 new customers.

When is the promotional period?

The promotional period is March 23 through April 30, 2019. Active Reps must meet the first qualification requirement, to make at least 2 personal sales of any DreamTrips® Membership level, between March 23 and 31, 2019. The remaining 4 personal sales must be made by April 30, 2019.

Which markets can participate in this promotion?

This promotion is available in all markets. Reps must be Active and in good standing during the promotion period to participate.

What are the requirements for qualification?

1. Make at least 2 personal membership sales of any DreamTrips Membership level between March 23 and 31, 2019.
2. Make at least 4 more personal membership sales of any DreamTrips Membership level, for a total of 6 personal sales by April 30, 2019.

Sales are subject to 2 payments (initial plus 1 month) being received and not refunded in order to count as a qualifying sale. The second payment must be successfully processed by June 4, 2019.

Will a Rep who missed the first requirement have a second chance to qualify for the promotion?

Yes. If a Rep who joined before April 1, 2019, makes at least 2 personal membership sales between April 12 and 14, 2019,

and makes at least 4 additional personal membership sales during the month of April 2019, they will qualify for a share of their region's bonus pool.

Can a Representative participate in Pick Up Six if they join WorldVentures on or after April 1, 2019?

Yes. If a new Representative joins WorldVentures on or after April 1, 2019, they must make all 6 of their required personal sales by April 30, 2019, to qualify for the promotion.

Do upgrades and reactivations count for the promotion?

No. Only new membership sales qualify toward the required 6 sales. Upgrades and Welcome Back reactivations do not count toward qualification.

How will the bonus payout be determined?

Any Representative who meets the requirements for qualification will be eligible for 1 share of a \$300,000 bonus pool, split between 3 regions (i.e., \$100,000 for each region). A Rep account can only qualify for a share in one of the region pools, determined by where the Rep account is registered.

Is it possible to earn more than one share in the bonus pool?

Yes. Every additional 3 personal membership sales (beyond the original 6 personal sales required), who make at least 2 payments, will earn the Representative an additional share in the pool.

Is it possible to earn a half-share in the bonus pool?

If a Rep registered in the Americas makes 3 personal membership sales between April 25 and 30, 2019, they will earn a half-share of the Americas' bonus pool.

What are the three regions, and which markets make up each one?

Region 1 covers North America, South America and the Caribbean. Region 2 covers Europe, the Middle East and Africa. Region 3 covers the Asia-Pacific region. See below for a breakdown of market assignments.

When will the bonus be awarded?

The bonus payout will be included in the June monthly commission run, paid on July 15, 2019.

Will my personal membership sales still generate commissions?

Yes. The compensation plan will remain unchanged during this promotion. Membership sales will continue to create bonuses through the Compensation Plan.* For example, any Rep who makes at least 6 personal membership sales during the promotional period may also be eligible to earn the following commission bonuses and promotional perks:

- \$120 Direct Commission
- \$200 Rising Star Bonus (eligibility is limited — see Compensation Plan for details)
- A chance to book a room on one of the Mega Rockstar Trips (while supplies last)*
